ADDENDUM NO.1 to the BIDDING DOCUMENTS

The Purchaser will respond in writing to any request for clarification received no later than **twenty-one (21) days** prior to the deadline for submission of bids. Late requests for clarifications received after this date will not be taken into consideration.

The bidders are especially encouraged to raise questions if they find any of the technical specifications unclear, too restrictive or proprietary by indicating the item, and the issue with a particular specifications requirement. All questions related to the quality of technical specifications must be raised prior to the bids submission deadline for ensuring enough time for the Purchaser for responses so that these can be addressed early.

No questions or complaints regarding technical specifications will be entertained after the bids submission deadline.

A pre-bid meeting, which prospective bidders may attend will be held at 14:00 hours local time, on June 30, 2017.

The Purchaser will assure sufficient time (minimum 10 days) for the preparation and submission of bids after sending the responses to the clarifications requests.”

Article 4: The paragraph 6 in the Invitation for Bids, at page 128 of the Bidding Documents, is hereby modified and shall be read as follows:

Bids will be publicly opened in the presence of the bidders’ designated representatives and anyone who choose to attend at the address (2) below at **14:00 hours local time on August 25th, 2017**.”

All other parts, clauses and provisions of the original Bidding Documents that are not amended as per the articles above shall remain valid and unchanged.
