The nominations of the competent authorities and, where applicable, affiliated entities **per Action** must be submitted by the competent authorities responsible for health in the Member States and in third countries associated to the EU4Health Programme via the **EU Survey platform**.

The **deadline** for nomination submission is **strict and final**.
